

2027 Jefferson Certification Instructions

Agent Certification launches July 16th

To begin your 2027 certifications, please follow the steps below.

Note: The Evolve platform works best when using **Google Chrome**.

Step 1: Complete AHIP

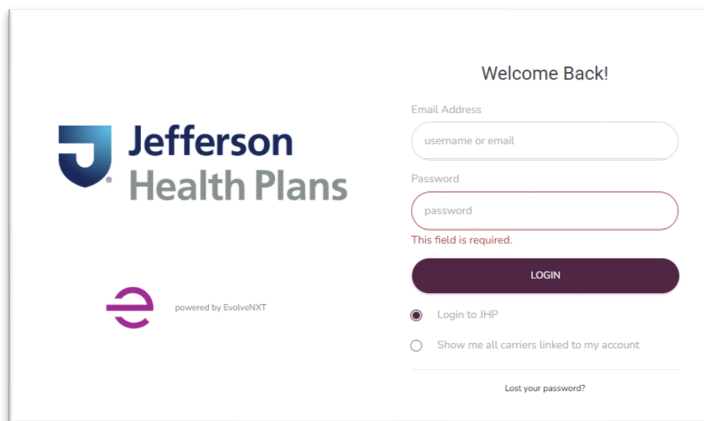
1. Complete the 2027 AHIP Medicare Training (**required**).
2. Use the following link to complete your 2027 AHIP Medicare training or training or transmit your AHIP scores to Jefferson Health Plans (JHP). Alternatively, you can complete this step during the **My Certification Case** process in the JHP portal.

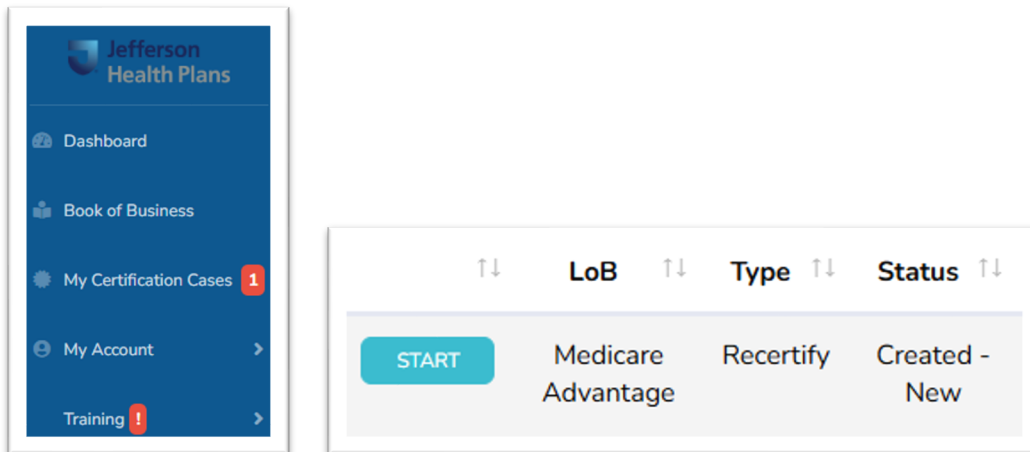
3. You must achieve a passing score of 90% or higher.
4. Completing AHIP satisfies the **CMS Medicare and Fraud, Waste & Abuse (FWA)** training requirements.

Step 2: Complete Jefferson Certifications

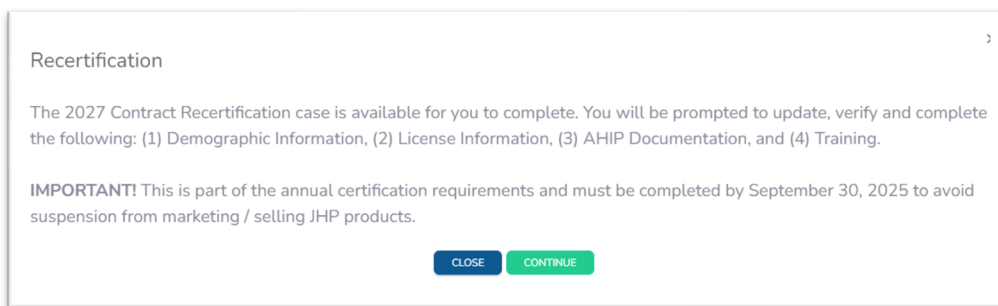
1. Log in to the **JHP Agent Portal**: [JHP Dashboard](#)



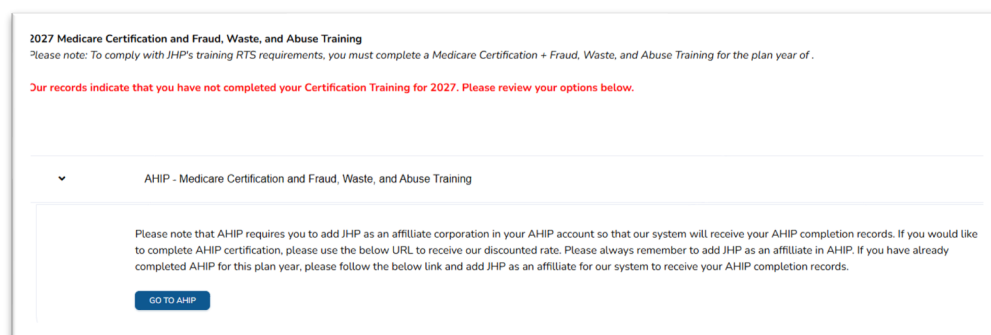
2. From the dashboard, select **My Certification Cases**, then click **Start**.



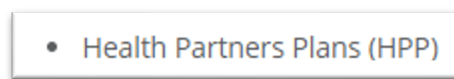
3. When the **Recertification** window appears, select **Continue** and review your information. Confirm or update your details as needed.



4. In the **Medicare Certification** window, select **GO TO AHIP** to complete the 2027 AHIP Medicare Training or transmit your AHIP scores.



5. Once redirected to the AHIP website, select **Health Partners Plans (HPP)** to ensure your training scores are correctly associated with Jefferson Health Plans. Please allow 24 hours for your AHIP completion and scores to upload to the Jefferson Health certification system.



6. After your **My Certification Cases** submission is successful, you will receive a confirmation message. Select **Go To Training** to access the **Required Training** window.
